## C. Reiteration on the Responsibility of the Bidders to confirm existing servers with the CIC.

Section II. It shall be understood that bidders shall not divulge or disseminate any information obtained to other parties and shall observe confidentiality at all times.

Amendments and clarifications made herein shall be considered an integral part of the Public Bidding Documents – PB19-005 and its terms and conditions. Any provision inconsistent herewith is hereby amended, modified, and superseded accordingly.
