II. Call to Order

The Pre-Bid Conference for the Renewal of Managed Firewall Services under Project No. 2021-CIMS(017)-PB-037 of the Credit Information Corporation was called to order on 15th of September 2021 at 2:00 P.M. and held via Webex Meeting. The BAC Secretariat documented the minutes of the meeting.

III. Certification of Quorum

Ms. Maria Bernadette B. Bautista, the BAC Chairperson certified that the quorum of the BAC was present to transact business. She acknowledged the presence of the BAC members, Technical Working Group, Resource Person, BAC Secretariat, Observers and Prospective Bidders.

IV. Highlights of Discussion

Ms. Jessa B. Buela presented a brief description of the project and elaborated the salient features of the Bidding Documents.

Ms. Buela discussed and elaborated the general requirements for Government Procurement specifically Project No. 2021-CIMS(017)-PB-037 in line with the Revised Implementing Rules and Regulations of the Republic Act (RA) 9184 with the purpose of clarifying questions of the procurement at hand and to interpret the technical requirements for the fully understanding of the prospective bidders.

Ms. Buela also mentioned that any statement issued during the pre-bid conference will not be binding unless it is put in writing and issued through a bid bulletin. Valid amendments and clarifications shall be issued through a supplemental/bid bulletin only.

Ms. Buela emphasized the importance of sequencing of documents in envelope for efficient opening of the bids.

Ms. Buela also stressed the no contact rule policy.

"Members of the BAC, including its staff and personnel, as well as its Secretariat and TWG, are prohibited from making or accepting any communication with any bidder regarding the evaluation of their bids until the issuance of the Notice of Award. However, the BAC, through its Secretariat, may ask in writing the bidder for a clarification of its bid. All responses to requests for clarification shall be in writing."

The BAC Chairperson announced that the floor was open to queries or other concerns coming from the prospective bidders.
