# ANNEX "B"

### COMPLIANCE FORM Technical Specifications

#### 1. Overview

The Credit Information Corporation (CIC) is mandated to collect and aggregate borrower's credit data to establish the credit worthiness of borrowers. In order to maintain the availability of the systems, CIC needs to have a reliable Uninterruptible Power Supply (UPS) that provides backup power when regular power source fails or voltage drops to an unacceptable level.

#### 2. Purpose

The CIC aims to purchase UPS in replacement for the defective unit installed in Executive Office.

#### 3. Scope

The procured units will be installed in Executive Office with a warranty of 3 years for repair on UPS and 2 years for battery.

## 4. Definition of Terms

Term	Definition
Uninterruptible Power Supply	It is an electrical apparatus that provides emergency power to a load when the input power source or <u>main</u> <u>power</u> fails.
Line Interactive	It maintains the inverter in line and redirects the battery's DC current path from the normal charging mode to supplying current when power is lost.
Service Level Agreement (SLA)	A commitment between a service provider and a client. Particular aspects of the service – quality, availability, responsibilities – are agreed between the service provider and the service user

#### 5. Duties and Responsibilities

#### 5.1. Service Provider (SP)

The SP's responsibilities with respect to this project are as follows:

 The delivery and installation of units must be completed within thirty (30) calendar days from the receipt of the Notice to Proceed (NTP). Otherwise, the SP shall pay a penalty in the amount of one tenth of one percent (1/10 of 1%) of the total contract price for every calendar day of delay.

2. Provide 8x5 technical support facility and capability.

## 5.2. Credit Information Corporation

CIC's responsibilities with respect to this project are as follows:

- 1. Grant the SP's authorized representative access to its premises, equipment and facilities located therein to perform its obligations, provided that such representative shall be accompanied by the duly assigned personnel of the CIC Technical Support Department.
- 2. Secure the necessary access pass and building permit required by the building administrator and assumes responsibility for the safe custody and use of the equipment installed by the SP.
- 3. Monitor the provided services and verify if the parameters under the Service Level Agreement are met and performed by the SP.
- 4. Issuance of a Certificate of Inspection and Acceptance to the SP upon successful completion of the testing certifying that the SP conforms to all requirements stipulated in this document.
