1. **Overview**

The Credit Information Corporation (CIC) is a Government-Owned and Controlled Corporation (GOCC) created in 2008 by virtue of Republic Act No. 9510 otherwise known as the Credit Information System Act (CISA). The CIC is mandated to establish a comprehensive and centralized credit information system for the collection and dissemination of fair and accurate information relevant to, or arising from credit and credit-related activities of all entities participating in the financial system, such as but not limited to retail, trade, utilities, and other service and product providers that may yield data on creditworthiness and payment behavior.

2. **Purpose**

The CIC aims to renew and acquire additional license for annual basic maintenance for existing backup solution.

3. **Scope**

The paid license covers to get the latest major releases, product updates and patches and 24/7 problem resolution support.

4. **Responsibilities of the CIC**

CIC's responsibilities with respect to this project are as follows:

1. Grant the Service Provider's authorized representative access to its premises, equipment and facilities located therein to perform its obligations, provided that such representative shall be accompanied by the duly assigned personnel of the CIC Technical Support Department.
2. Secure the necessary access pass and building permit required by the facility administrator and assume responsibility for the safe custody and use of the equipment installed by the Service Provider.
3. Monitor the provided services and verify if the parameters under the Service Level Agreement are met and performed by the Service Provider.
4. Issuance of a Certificate of Inspection and Acceptance to the Service Provider upon successful completion of the testing certifying that the Service Provider conforms to all requirements stipulated in this document.
5.
