**COMPLIANCE FORM
TERMS OF REFERENCE**

1. Overview

The Credit Information Corporation (CIC) is mandated to collect and aggregate borrower's credit data to establish the creditworthiness of borrowers. Endpoint Protection Solution plays an important role in the collection and data processing activities of the CIC. Thus CIC needs an endpoint security solution to proactively identify at-risk files and stop zero-day threats without slowing down system performance.

CIC uses the endpoint security solution with the following features:

- a) Analyzes incoming data streams and proactively blocks threats
- b) Analyzes file reputation and separates at-risk from safe files for faster and accurate detection
- c) Analyzes application behavior and monitors it in real-time and stops targeted attacks and zero-day threats
- c) A strong anti-virus, anti-spyware and firewall protection
- d) An optimized solution for strong performance in both physical and virtual environments
- e) A central management console across physical and virtual platforms with granular policy control

2. Purpose

The CIC aims to renew the license for endpoint protection solutions to continually provide an easy-to-manage technology that integrates with other security solutions of the CIC to improve its overall security while overcoming its limited budget and manpower resources.

3. Scope

The paid license covers to receive security content updates, product updates and versions, and access to Technical Support for one year.

4. Definition of Terms

Term	Definition
Anti-virus*	Also known as anti-malware, is a computer program used to prevent, detect, and remove malware.
Anti-spyware*	It is a type of malware that aims to gather information about a person or organization, without their knowledge, and send such information to hack another entity without the consumer's consent.
Service Level Agreement (SLA)*	A commitment between a service provider and a client. Particular aspects of the service – quality, availability, responsibilities – are agreed between the service provider and the service user

5. Duties and Responsibilities

5.1 Service Provider (SP)

The SP's responsibilities for this project are as follows:

1. The renewal and installation of the license must be completed within thirty (30) calendar days from the receipt of the Notice to Proceed (NTP). Otherwise, the SP shall pay a penalty in the amount of onetenth of one percent (1/10 of 1%) of the total contract price for every calendar day of delay.
2. Fine-tune, correct, and/or enhance as may be needed to address business requirements
3. Correct/fix any system problems identified within the agreed service level
4. Provide Service Delivery Manager (SDM) as a single point of contact for technical support and service delivery concerns. The SDM shall notify the CIC seven (7) days before any scheduled maintenance and other service interruption.
5. Provide an 8x5 technical support facility and capability, consisting of an online help-desk facility and competent technical support personnel as described in Section 5.3.

5.2 Credit Information Corporation

CIC's responsibilities for this project are as follows:

1. Grant the SP's authorized representative access to its premises, equipment, and facilities located therein to perform its obligations, provided that such representative shall be accompanied by the duly assigned personnel of the CIC Technical Support Department.
2. Secure the necessary access pass and building permit required by the building administrator and assumes responsibility for the safe custody and use of the equipment installed by the SP.
3. Monitor the provided services and verify if the parameters under the Service Level Agreement are met and performed by the SP.
4. Issuance of a Certificate of Inspection and Acceptance to the SP upon successful completion of the testing certifying that the SP conforms to all requirements stipulated in this document.
5. Pursuant to General Procurement Policy Board (GPPB) Resolution No. 019-2006 dated 06 December 2006, at the end of each year, the CIC will conduct an assessment of the quality of service provided particularly the cost charged by the SP and the range of services it offers against other service providers in the area.
6. Conducts assessment/evaluation of the SP 60 days before the end of the contract.
