The CIC is mandated to establish a comprehensive and centralized information system for the collection and dissemination of fair and accurate information relevant to, or arising from credit and credit-related activities of all entities participating in the financial system, such as but not limited to retail, trade, utilities, and other service and product providers that may yield data on creditworthiness and payment behavior.

2. Purpose

The CIC aims to renew the license for annual basic maintenance for existing backup solution.

3. **Scope**

The paid license covers to get the latest major releases, product updates and patches and 24/7 problem resolution support.
